1. Introduction

We are committed to safeguarding the privacy of our website visitors; in this policy we explain how we will treat your personal information.

2. Collecting personal information

We may collect, store, and use the following kinds of personal information:

- 3.9. We will not, without your express consent, supply your personal information to any third party for the purpose of their or any other third party's direct marketing, nor for any other purpose except those listed below in "Disclosing personal information" section below.

- 6.2. Information that we collect may be transferred to the following countries which do not have data protection laws equivalent to those in force in the European Economic Area: Russia.
- 6.3. You expressly agree by providing your personal information to the transfers of this information described in Section 3.

7. Security of personal information

- 7.1. We will take reasonable technical and organisational precautions to prevent the loss, misuse or alteration of your personal information during storage, transmission, processing, etc.
- 7.2. We will store all the personal information you provide on secure servers.
- 7.3. You acknowledge that the transmission of information over the internet is inherently insecure, and we cannot guarantee the security of data sent over the internet.

8. Use of cookies by this website

- 8.1. Cookies are small text files that are placed on your computer by websites that you visit. They are widely used in order to make websites work, or work more efficiently, as well as to provide information to the owners of the site.
- 8.2. A number of the cookies that we use on the website are essential for parts of the site to operate and some have already been set. You may delete and block all cookies from the site, but parts of the site may not work.
